### WAIVER AND RELEASE OF LIABILITY

In consideration of the acceptance by MDAM of this application, and/or in consideration of the permission granted by MDAM to the undersigned to participate in MDAM activities,

I, THE UNDERSIGNED, HEREBY AGREE AS FOLLOWS:

1. I hereby acknowledge the importance of, and shall at all times observe and keep, all of the rules and regulations of MDAM with respect to safety and otherwise.
2. I hereby accept and voluntarily assume sole responsibility for all my actions and/or omissions to act in connection with all MDAM activities (including without limitations all games, competitions, classes and other functions), and hereby assume all risk of death, injury, loss, or damage to persons or property which arise out of, are caused by, or result from all such actions and/or omissions to act.
3. I hereby release, remise, completely resolve and forever discharge and agree to indemnify and save harmless all agents, officials, authorities, officers, representatives, instructors, students, and designates, whether volunteer or otherwise, from and against all claims, actions, suits, costs, expenses, and demands, whether as a result of death, injury, loss, or damage to persons or property or otherwise, and regardless of how any such death, injury, loss, or damage is caused, which arises out of, is caused by or results from my participation directly or indirectly in all MDAM activities (including without limitations all games, competitions, courses, classes, and other functions) even if the cause of such death, injury, loss, or damage may have been contributed to in whole or in part by the negligence of MDAM, its promoters or sponsors, or any of its respective agents, officials, authorities, officers, representatives, instructors, students, or designates, whether volunteer or otherwise, or by the breach or violation of any law, statute, bylaw, rule, regulation, or other lawful authority whatsoever.

I hereby covenant and agree not to make any demands, or claims, or bring any suit or actions against MDAM, its organizers, promoters, or sponsors, or any of its respective agents, officials, authorities, officers, representatives, instructors, students, or designates, whether volunteer or otherwise, with respect to any event whatsoever arising out of, caused by or resulting from my participation directly or indirectly in any MDAM activity (including without limitation all games, competitions, courses, classes and other functions).
5. I hereby acknowledge and agree that this Waiver and Release of Liability is binding upon myself and my heirs, executors, assigns, and invitees.

#### **Cancellations/Wait List:**

1. All accepted registrations are subject to a \$25.00 cancellation fee.
2. There will be no refund for cancellations made 7 days or less prior to the commencement of a course. (Exceptions to this rule may be made if cancellation is due to injury or illness, at the discretion of MDAM).
3. Without exception, there is no refund once a course has commenced.
4. If you are placed on a wait list, your interest in enrolment is assumed unless MDAM is notified otherwise. When a vacancy arises, you will automatically be enrolled in the course and notified of your enrolment.

#### **General Terms:**

Participants will be responsible for damage to any equipment caused by recklessness, carelessness and/or wilful misconduct. At the sole discretion of the Head Camp leader, any participant whose conduct is considered inappropriate may be suspended. No refund will be issued to participants who are suspended.
